## WHAT DOES NEBRASKA COMMUNITY FOUNDATION DO?

NCF assists professional advisors and their clients with charitable gift planning in more than 250 hometowns across the state. Through a growing grassroots network of over 1,500 volunteers, we unleash abundant local assets, inspire charitable giving, and connect ambitious people to build stronger communities and a Greater Nebraska.

#### HOW DOES NCF WORK?

NCF is a statewide organization with more than 200 affiliated funds. NCF's 501(c)(3) tax-exempt status allows donors to affiliated funds to receive tax deductions for their contributions. We provide a range of services, including financial management, strategic development, and training to our affiliated funds. This enables local leaders to focus their efforts on cultivating charitable giving and making high-impact grants within their communities and organizations.

### WHAT TYPES OF FUNDS DOES NCF OFFER?

NCF provides development and professional services to affiliated funds located across the state. These include community-based funds—primarily in rural areas—and organizational funds, such as hospital, school, and library foundation endowments; and statewide economic development, leadership, volunteerism, and

environmental endowments. We also manage funds for several public/private partnership programs involved in restoring several of Nebraska's most important natural resources. NCF also serves numerous donor-driven funds, through which individual donors, families or corporations make charitable gifts to benefit their communities and favorite charities.

### HOW ARE DONOR-DRIVEN FUNDS CREATED?

These may be established as a donor-advised fund or a donor-designated fund.

With a donor-advised fund, the donor or a Fund Advisory Committee is actively involved in recommending grants from the fund to support communities or charitable activities that are of interest to them. One arrangement is to set up a gift as a permanent endowment in which the principal is invested, with a portion of the investment earnings used to make grants —thus assuring perpetuity. The other arrangement is known as a non-permanent fund, where the principal and all investment earnings are available to make grants.

With a donor-designated fund, a donor makes a gift to establish a permanent endowment and designates specific charitable organizations to receive the endowment payout. This provides income for the designated charitable recipients in perpetuity.

# CAN A PRIVATE FOUNDATION BE CONVERTED TO A DONOR-DRIVEN FUND?

Some private foundations have chosen to dissolve and distribute their assets to a donor-driven fund of Nebraska Community Foundation. There are many tax and administrative benefits associated with this change.

### WHAT ELSE SHOULD I KNOW ABOUT NCF?

NCF was established in 1993 and is governed by a volunteer board of directors made up of diverse community leaders from across the state. NCF is heralded as a model for community foundations. Its groundbreaking work in using the intergenerational transfer of wealth as a call to action has been widely acclaimed by leading philanthropic organizations nationwide.

Nebraska Community Foundation staff includes professionals in finance and accounting, planned giving, community development, education and communications.
